#### About us

We need to engage better with local communities and to articulate CPRE's purpose in a positive, solution-focused way,

making the case for the enhancement, sustainability, promotion and protection of our countryside.

#### **About the Role**

Our present Treasurer, who is a chartered accountant, has been in post since 2015 and is required to retire in spring 2024 under the terms of our Constitution. We are looking for a new treasurer to join our Board of trustees to undertake the essential role of planning and accounting for our finances to ensure the long-term sustainability of our charity. The role involves providing well-grounded advice to the Board, ensuring the charity's financial resources meet its present and future needs and that there are proper accounting procedures and controls in place. It also involves overseeing the preparation and examination of the annual accounts.

You will join a friendly, experienced and knowledgeable Board of Trustees. We have a modest budget and a small office which is currently based in Community House close to the Cathedral in the centre of Gloucester.

## Responsibilities

The Treasurer is responsible for keeping the Board appraised of the charity's financial health.

- Advising on the financial implications of our plans.
- Overseeing the presentation of budgets, internal management accounts, and annual financial statements.
- Ensuring proper accounting records are maintained and appropriate accounting procedures and controls are in place.
- Ensuring CPRE Gloucestershire complies with relevant legislation, regulations, and financial reporting requirements.

As a Trustee, the Treasurer shares the general responsibilities of trustees to:

- Safeguard and promote the reputation, vision, mission, and values of CPRE Gloucestershire.
- Ensure CPRE Gloucestershire complies with its governing documents, relevant legislation, and regulatory requirements.
- Help set the overall strategic direction of CPRE Gloucestershire by agreeing on organisational policies, budgets, and objectives, ensuring targets are set, and performance is measured against those targets.
- Ensure that key risks are identified, monitored, and controlled effectively.

### **Person Specification**

Given the particular role of the Treasurer, we are seeking someone who has:

- experience in financial management and accountancy, ideally but not necessarily as a qualified accountant.
- A passion for environmental and countryside issues in support of CPRE's mission to 'promote, enhance and protect a thriving countryside'
- Proven ability to communicate and explain financial information to non-finance professionals, members, the Board, and other stakeholders.
- A collaborative attitude and ability to work well with the Board, staff, and volunteers.
- Good independent judgment and analytical and evaluation skills.
- Understanding and acceptance of the legal duties, responsibilities, and liabilities of being a Trustee.
